### **Job Description**

Post Title:	SENCO

#### Areas of Responsibility and Key Tasks:-

In addition to the responsibilities noted below, the post has the job description and responsibilities of a classroom teacher.

#### Additional Responsibilities:-

- To ensure that SEND facilities and provision are effectively lead and managed
- To ensure all statutory and legal requirements are met for pupils with SEND
- To take day to day responsibility for the provision for pupils with SEND and provide professional guidance to staff in the area of SEND
- Develop a systematic whole school approach to the needs of pupils with SEND
- Monitor the quality of SEND support and teaching (TA's and teachers)
- Liaising with and co-ordinating the contribution of external agencies for SEND pupils and provision
- Monitor the attainment and progress, as well as the welfare and well-being of pupils with SEND
- Support and influence teaching to promote inclusion
- Lead on CPD to support staff in maximising achievement for SEND pupils
- Co-ordinate special arrangements in external examinations for pupils with specific requirements
- Support and develop initiatives to improve standards of literacy and numeracy
- Oversee and monitor the quality of IEP's, reviewing and updating these as necessary
- Coordinate and lead on High Needs Funding applications
- Have the overview of the Pupil Premium Strategy
- Lead your team to continual improvement of provision, line managing all TA's in Hadlow Rural Community School
- Develop systems and infrastructure to ensure ease of communication and fulfilment of statutory responsibilities
- Deploy resources (human and otherwise) effectively to maximise the achievement of pupils with SEND
- To attend and contribute to staff meetings
- To take part in and contribute in delivery of INSET

- To develop and co-ordinate a system of assessment within your subject area, including tracking and intervention of pupils
- To be responsible for the review, development and purchase of resources for your subject
- To support the pastoral work of the school including, if required, as a form tutor
- To perform an equitable share of duties
- To participate and attend meetings with parents and colleagues as necessary and required by directed time
- To participate in the school's Performance Management System possibly as a reviewer of more junior colleagues
- Ensure the School's Health and Safety policies and regulations are adhered to by all staff and pupils
- Work to promote and contribute to the School's Equal Opportunities Policies
- Contribute and promote safeguarding at all times, to ensure the safety and security of pupils, staff and stakeholders
