# JOB DESCRIPTION



Job Title: Lunchtime Supervisor

Grade: SAT 2

Line Manager to: Senior Assistant Headteacher –

**Principal of Communities** 

#### Purpose of the Job:

To undertake duties in support of the Headteacher to ensure effective supervision of students during their lunch break.

## Main duties and responsibilities (Accountabilities):

- To be responsible for the supervision of students during the interval between the end of the morning session and recommencement of the school in the afternoon.
- To supervise designated areas during lunchtime in order to make lunchtime discipline as efficient as possible (please refer to the current duty rota).
- To deal with incidents and issue sanctions as appropriate.
- To report serious incidents to Senior Leadership Team (SLT) or Pastoral Support Teams.
- If intruders come on to school site, to contact SLT and / or senior staff as a matter of urgency.
- At the end of lunchtime, to assist and monitor the orderly dismissal of students as they return to classrooms.
- To direct students to put litter in the bins provided.
- To ensure students are meeting health and safety requirements as stipulated in rules and The North School message and The North School site code.
- To undertake such additional or altered duties as Deputy Head in charge of duties or Headteacher may reasonably assign.
- To actively encourage and support students in looking after the fabric of the school and its environment.

#### It should be noted that:

- (i) A Lunchtime Supervisor is on duty for the full lunch period. 60 minutes of duty will be "active" in designated area. "Active" duty means the Lunchtime Supervisor will engage with students on a regular basis reinforcing behaviour and directly challenging incidents of poor behaviour.
- (ii) The Lunchtime Supervisor is expected to maintain a calm, well-ordered atmosphere in the area(s) of their duty. The Lunchtime Supervisor will be responsible for reporting any acts of misbehaviour or indiscipline to senior staff on duty.

#### The Shortlisting and Interview Process

- Where appropriate any documentation evidencing change of name
- Certificates of educational or professional qualifications that are necessary or relevant for the post

#### **Conditional Offer**

Any offer of employment will be conditional upon a number of formalities, including, but not restricted to the followina:

- Verification of right to work in the UK
- Receipt of two satisfactory references
- Verification of identity checks and qualifications
- Satisfactory enhanced DBS check, as well as additional checks that may be appropriate if you have worked or been resident overseas in the previous five years
- Satisfactory pre-employment health clearance
- A check against the Teacher Service Register for any teaching prohibition or restriction orders where
  you are applying for a teaching role or if you have previously held a teaching role in past
