Full training will be provided to the successful candidate. This is also an ideal opportunity for potential teaching candidates to gain experience before making a training application. Salary Grade:	Kent Range 5, £22,595 to £23,693 FTE (pro rata £16,958 to £17,782 approximately)
Hours/week:	Monday to Friday 32.5 hours per week (8:25 am – 3:25 pm)
Weeks/year:	Term time only plus 2 non-pupil days, 38.4 weeks per year

Overall Responsibility

- To cover lessons and be responsible for the whole class in the absence of the regular class teachers – this will involve delivering the set work, monitoring the class and making sure students are kept on task and behaving appropriately
- To be visible in the corridor at times of lesson changes and to secure good behaviour
- When not covering lessons, support the whole school administration as directed by the Assistant Headteacher who oversees cover or by the Headteacher.
- On a daily basis, cover supervision is likely to include:
 - Supervising work that has been set in accordance with the school policy
 - Managing the behaviour of students whilst they are undertaking this work to ensure a constructive environment
 - Ensuring the behaviour policy and procedures are implemented
 - Ensuring attendance registers are taken
 - Ensuring the classroom environment is safe in terms of safeguarding and health and safety
 - Responding to any questions from students about processes and procedures
 - Dealing with any immediate problems or emergencies according to the school's policies and procedures
 - Collecting any completed work after the lesson and returning it to the appropriate teacher
 - Reporting back as appropriate using the school's agreed referral procedures on the behaviour of students during the class, and any issues arising or cause for praise.
