Valence School Job Description: PRIMARY TEACHER (1 YEAR FIXED TERM- MATERNITY COVER)

Responsible to: Assistant Principal (Curriculum)

Responsible for: Class Coordinator/Student Support Assistants

This post is subject to the professional duties and conditions of the service set out in the current DfE School Teachers' Pay and Conditions Document. The post holder is expected to undertake duties in line with the professional standards for qualified teachers.

Main purpose

To be able to teach and assess pupils within the primary phase. To deliver a bespoke curriculum as required by the school to ensure appropriate progress of students. To work flexibly and creatively to deliver lessons to students across primary.

Duties and responsibilities

- To teach a primary curriculum, in consultation with the lead teacher.
- To maintain appropriate record keeping in relation to students' curriculum and EHCP targets.
- To work in conjunction with the Teaching and Learning Leadership Team (TLLT) to
 ensure the provision of high quality teaching and learning opportunities, to meet
 statutory requirements, the individual special educational needs and aspirations of
 the students.
- To encourage, enable and promote effective communication with students, staff, parents and other departments in order to secure efficiency and high standards of achievement for students.
- To carry out tasks in order to ensure that the school runs effectively. This will include health & safety and other areas delegated by Senior Staff.
- To undertake all professional duties as set out in the 'School Teachers' Pay and Conditions Document' and, where applicable, relevant 'Performance Threshold Standards'
- To carry out other reasonable duties as required by the Line Manager and maintain a flexible "can do" approach.
- To ensure that communication with students, staff, and other multi-disciplinary departments is effective and contributes to securing efficiency and high standards of care and personal development for students within the primary phase.
- To maintain high standards of safety and observe good practice in relation to health and safety and safeguarding in all issues and report any concerns to line management.

• To pro-actively observe and comply with all school policies and procedures relating to child protection, equality and diversity, health, safety and security, confidentiality and data protection reporting all concerns to an appropriate person.

It is in the nature of the work of special schools that many tasks and responsibilities are unpredictable and varied. All teachers are, therefore, expected to work in a flexible way and when occasions arise, to undertake tasks not specifically covered in their job description.

Please note that this is illustrative of the general nature and level of responsibility of the work to be undertaken, commensurate with the grade. It is not a comprehensive list of all tasks that the postholder will carry out. This job description may be amended at any time in consultation with the postholder.

This role involves contact with and responsibility for children and young people and will be engaged in regulated activity. The law requires this position to have an enhanced criminal background check. This is to protect children and vulnerable adults and to safeguard positions of trust. The position is therefore exempt from the Rehabilitation of Offenders Act. If your application is taken further you will be asked to declare details of any criminal record, even convictions that are 'spent' according to the act. If you are offered the post this information will be checked against DBS.
