#### **Key Duties and Responsibilities**

#### Teaching

- Plan and teach well-structured lessons to assigned classes, following the school's plans, curriculum and schemes of work
- Assess, monitor, record and report on the learning needs, progress and achievements of assigned pupils, making accurate and productive use of assessment
- > Adapt teaching to respond to the strengths and needs of pupils
- > Set high expectations which inspire, motivate and challenge pupils
- Promote good progress and outcomes by pupils
- > Demonstrate good subject and curriculum knowledge
- > Participate in arrangements for preparing pupils for external tests

#### Whole-school organisation, strategy and development

- Contribute to the development, implementation and evaluation of the school's policies, practices and procedures, so as to support the school's values and vision
- Make a positive contribution to the wider life and ethos of the school
- Work with others on curriculum and pupil development to secure co-ordinated outcomes
- > Provide cover, in the unforeseen circumstance that another teacher is unable to teach

### Health, safety and discipline

- Promote the safety and wellbeing of pupils
- Maintain good order and discipline among pupils, managing behaviour effectively to ensure a good and safe learning environment

#### **Professional development**

Take part in the school's appraisal procedures

- > Take part in further training and development in order to improve own teaching
- > Where appropriate, take part in the appraisal and professional development of others

## Communication

Maintain high standards of communication with colleagues, parents and pupils.
