## JOB DESCRIPTION

### Class Teacher

**Purpose:** All pupils at Grange Park at Stansted Primary School have a diagnosis of Autism Spectrum Condition; teachers must demonstrate an understanding and knowledge of this in their teaching practice and be able to:

- Teach throughout Key Stage 2 and some Key Stage 3 classes, meeting the pupils' autistic and academic needs
- Implement and deliver an appropriately broad, balanced, relevant and differentiated primary national curriculum.
- To monitor and support the overall progress and development of pupils as a teacher and coordinate the personal development of pupils in their class.
- To facilitate and encourage a learning experience which provides pupils with the opportunity to achieve their individual potential.
- Establish and develop links with Subject Leaders in mainstream and other special schools to promote the quality of whole school curriculum development.
- Show a commitment to the school and its improvement by supporting the school's target setting process to enhance teaching and learning, to increase standards of achievement and raise levels of pupil attainment.
- To adhere to whole school policies and procedures
- To maintain a professional attitude in all aspects of school life and including confidentiality regarding school matters
- Attend weekly staff meetings and additional meetings that are required to implement the School Development Plan.
- Have reporting responsibility to SLT/ Governors on School Improvement Issues related to areas of responsibility.

## MAIN (CORE) DUTIES

### Teaching:

1. To set high expectations which inspire, motivate and challenge pupils.
2. To teach, pupils according to their educational needs, including the setting and marking of work to be carried out by the pupils in school.

4. To use daily assessments to inform the next steps for pupil's learning.

7. To ensure a high quality learning experience for pupils which meets internal and external quality standards.
8. To prepare and update curriculum resources.
9. To use a variety of delivery methods which will stimulate learning appropriate to pupil needs and demands of the syllabus.
10. To maintain discipline in accordance with the School's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.
11. To undertake assessment of pupils as requested by external examination bodies and School procedures.
12. To mark and provide written/verbal and diagnostic feedback in line with the school marking policy.

### Operational/ Strategic Planning

1. To assist in the development of the national curriculum, resources, schemes of work/medium term plans, marking policies and teaching strategies within the curriculum area and in a wider context where necessary.
2. To contribute to the School Development Plan
3. To plan and teach well- structured lessons
4. Adapt teaching to respond to the strengths and needs of all pupils
5. To contribute to the whole School's planning and development activities.
